





#### **COOPERATION AGREEMENT**

**UNIVERSITY OF VERONA,** located in Verona (Italia), Via dell'Artigliere, 8, represented by its Rector, Professor Pierfrancesco Nocini;

THE INTERDEPARTMENTAL SKENÈ CENTRE located in Verona (Italia), Lungadige Porta Vittoria 41, represented by its Director, Professor Silvia Bigliazzi;

and

FACULDADE DE LETRAS – UNIVERSIDADE DE LISBOA (School of Arts and Humanities – ULisboa), hereby referred to as FLUL, located at Alameda da Universidade, 1600-214 Lisboa, represented by its Dean, Professor Doctor Miguel Bénard da Costa Tamen, and

THE UNIVERSITY OF LISBON CENTRE FOR ENGLISH STUDIES, hereby referred to as ULICES, a research unit of FLUL, located in Alameda da Universidade, 1600-214 Lisboa, represented by its Director, Professor Doctor Maria Teresa de Salter Cid Gonçalves Rocha Pires,

Agree to this Cooperation Agreement within the field of Medical Humanities, subject to the following clauses and conditions:

# Clause One (Object)

- 1 According to this agreement, FLUL, by means of ULICES, agrees to collaborate with the Interdepartmental Skenè Centre of the University of Verona within the broad field of Medical Humanities.
- 2 For the purposes of the previous paragraph, the signatory institutions agree to collaborate in the organisation of a variety of activities, subject to the approval of the Scientific Committees of Skenè and ULICES, as follows:
  - a) Research and scientific dissemination activities, such as lectures, conferences, publications, reading and writing groups;







- b) Educational activities, based on the collaboration in teaching activities to be defined, seminars, workshops;
- c) Cultural activities, such as cinema cycles, exhibitions, debates;
- d) Knowledge transfer activities, namely societal interventions in extra-academic contexts.

#### **Clause Two**

### (Beneficiaries)

The activities carried out under this agreement are intended for the students of FLUL and the students of the University of Verona and for teaching staff, researchers, students and other health professionals of both institutions.

### **Clause Three**

## (Execution)

- 1 Each activity shall be agreed between the parties in writing and attached to this agreement as an Addendum.
- 2 The participation of teaching staff and researchers bound by a civil service employment contract to any of the signatory institutions will not imply any increase in income.

#### **Clause Four**

#### (Costs and Expenses)

This agreement does not entail any costs and expenses on the part of both Partner Institutions, unless in specific cases that shall be settled by both signatory institutions by means of a specific agreement, as mentioned in Clause Three.

**Clause Five** 

(Validity)







The present agreement will come into force from the date of bilateral signature for a period of 5 years and can be renewed depending on the Parties' will. Termination must be made in writing with 30 days' notice to the other party, without prejudice to ongoing activities.

This Agreement is signed by the contracting parties in three copies in English language, identical in content and form, with equal juridical value.
